#### **SECTION 4: FIRST AID MEASURES**

**EYES:** Rinse cautiously with water for several minutes occasionally lifting the upper and lower eyelids. Check for and remove contact lenses, if present and easy to do. Continue rinsing for at least 20 minutes. Get medical attention.

**SKIN:** Flush contaminated skin with plenty of water. Continue to rinse for at least 20 minutes. Get medical attention. Take off contaminated clothing and wash before reuse. Clean shoes thoroughly before reuse.

# SECTION 6: ACCIDENTAL RELEASE MEASURES

#### Personal Precautions, Protective Equipment and Emergency Procedures
